A	<p><u>Football Governance Bill</u></p> <p>JM said that the Trust will look to feedback on IFR consultation around fan engagement principles in its own right before the 8 December deadline. Other Trusts that are affiliated with Trusts First are being encouraged to do the same.</p>
B	<p><u>East stand and land update</u></p> <p>No response still to the questions asked by the Trust of the club, in particular to concerns around matchday car parking at Sixfields next season. The Trust's non-statutory consultee submission made on 21 October has still not appeared on the planning portal and this will be followed up with WNC planners and our liaison representative Councillor John East.</p>
C	<p><u>Support for the NTFC Academy</u></p> <p>Ant Collett replied to our message about potential financial support for NTFC Academy saying that changes were taking place within the Academy's management structure and that he would await the appointment of new personnel before raising this and reporting back.</p>
